Cancellation of Seat/Admission

Admission of all such students who fail to attend at least 33% of the total lectures delivered and practicals held in all the papers during the first 10 working days from the start of teaching work in the course concerned shall be cancelled by the Board of Control/Joint Admission Cell after following the procedure appended of Handbook of Information given below:

- 1. By the 12th day after the start of classes for a particular course, the names of those students who fail to attend at least 33% of the total lectures/ tutorials/ practicals etc. shall be put up on the Notice Board and online Notice Board of the Department and also send a copy of the same to the office of the DUI. Within 4 days of the date of such notice, a student who is short of attendance may give in writing the reasons for his absence from the classes.
- 2. If a student does not submit an application in writing within the prescribed time as stated above, or the reasons adduced by the student in his application are not found to be sufficient and justified in the opinion of the Board of Control/joint Admission Cell, his admission shall be cancelled.
- All the seats thus falling vacant shall be filled strictly in the order of merit from the waiting
 list or through subsequent counselling before the expiry of the last date fixed for
 admissions by the University.
